The BWF Health & Safety Award acknowledges an individual or collective effort, or initiative, which has made a notable difference to the Health & Safety practices and culture within a business.

Judging Criteria

The Award will be judged against the following criteria:

- The company as a whole.
- An individual within the company.
- An initiative undertaken by the company.

The Award will be judged against any of the following criteria:

A focused outcome – An initiative or action that has improved safety in your business.

Adding value – Ability to demonstrate clear results from the initiative or actions.

Commitment – Evidence as to how this is linked to the commitment to Health & Safety in your business.

Entry Requirements

To enter, complete this Award entry form and submit with the following information:

- Tell us about the initiative, company, or individual that shows how the entry meets the criteria.
- Any supporting documentation to show how Health & Safety has been improved.
- A Photographs and any applicable technical drawings. If you are submitting an individual entry, please include a photo of the entrant. All photographs and/or drawings to be sent in a separate digital file – either JPEG or EPS format.

Judges Tips



- ✓ Describe the specific effort or initiative and demonstrate full company buy-in.
- ✓ Clearly address the judging criteria for the award.
- ✓ Include any new company policies, processes or practices that have resulted.
- ✓ Where possible, include any data that demonstrates the improvements achieved.
- ✓ Include high quality relevant photos – a picture tells a thousand words.

Entry Rules

- Award entries are invited for initiatives, companies or individuals that have provided a focused outcome, shown commitment and added value to Health & Safety in a business.
- For each award category, you can submit up to two entries per company.
- Nominations can be made directly by the individual or company, or you can nominate another individual or company.
- Previous winners of this award cannot be re-entered.
- Entry forms and all accompanying documentation must be received by no later than 17.00 on Friday 30th August 2024.
