The BWF Sustainability Award recognises outstanding projects, initiatives or individuals that demonstrate a commitment to improving the company's environmental sustainability performance.

Judging Criteria

The Award will be judged against the following criteria::

- The company as a whole.
- An individual for their specific contribution/leadership.
- A specific initiative or project undertaken by the company.

The Award will be judged against any of the following criteria:

Clear Thinking – Identifying achievable and lasting sustainability improvements.

Measurable Results – Measured evidence that sustainable environmental improvements have been made.

Commitment – Clear methodology and a well-managed process that demonstrates continued environmental sustainability improvement.

Entry Requirements

To enter, complete this Award entry form and submit with the following information:

- Give details about the initiative/company/individual that shows how the entry meets the judging criteria.
- Other supporting documentation which outline the sustainability initiative made.
- Photographs and any applicable technical drawings. All photographs and/or drawings to be sent in a separate digital file – either JPEG or EPS format.
- If you are submitting an individual entry, please include a photograph of the entrant.

Judges Tips



- ✓ Describe the problem, the considered solution and the desired outcome.
- ✓ Clearly address the judging criteria for the award.
- ✓ Detail any resulting new policies or processes that demonstrate commitment.
- ✓ Include data that clearly demonstrate the improvements achieved.
- ✓ Include high quality photos – a picture tells a thousand words.

Entry Rules

- Entries are invited for clear thinking, measurable results, commitment and adding value to a business by the introduction process and resource efficiencies. Examples might include initiatives that reduce the time required in manufacture or installation, or that reduce the waste resulting from manufacture or installation.
- You can submit an entry for an individual, company or project.
- For each Award category you can submit up to two entries per company.
- Nominations can be made directly by the company, or you can nominate another individual or company.
- Entries can be submitted for the same project in multiple Award categories.
- Entry forms and all accompanying documentation must be received by no later than **17.00 on Friday 30th August 2024.**
